I _____ being the parent/guardian of the player being registered hereby agree as follows:

1. I will conduct myself and endeavor to ensure others in my company conduct themselves in a proper and reasonable manner and in accordance with Basketball Victoria's Codes of Conduct, a copy of which is available from Basketball Victoria, the association or from Basketball Victoria's internet site www.basketballvictoria.com.au
2. I agree to be bound by the basketball association's and Basketball Victoria's constitution, rules and by-laws and the conditions of entry into the basketball facility and to submit myself to the jurisdiction of Basketball Victoria's Tribunal, Member Protection Tribunal and any other disciplinary forum connected with basketball.
3. I agree to comply with any reasonable direction of any official connected with basketball.
4. I acknowledge that I am aware that there will only be limited times when a person qualified in first aid is present.

I authorise the club, association, league or Basketball Victoria to obtain medical treatment for my child should there be an emergency and it is not possible or reasonably practical for me to do so and acknowledge that the cost of any ambulance or medical treatment will be my sole responsibility.
6. I will endeavor to be present or ensure a responsible adult is present at all games, training sessions and other basketball activities in which my child is involved.
